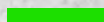

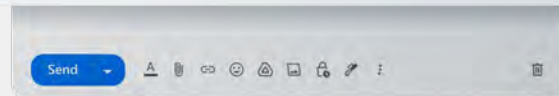
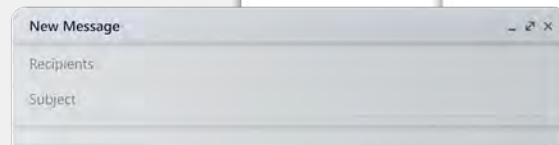

How do I know if this applies to my business

The rules differ based on your specific business activity. In particular, it is important to understand the relevance of the following topics to your specific circumstances:

1 Goods vs. Services
In general, professional services will not be subject to foreign VAT, even if your customers are located in a foreign country. Certain exceptions apply, but in most cases only businesses who trade in physical goods need to consider their VAT obligations abroad.

2 B2B vs. B2C
The VAT treatment of transactions between two tax-paying business entities (B2B) is vastly different to sales to private individuals (B2C). In general, there are simplifications in place to remove the foreign VAT burden on B2B transactions, whilst the requirements for B2C are far more clearly defined.

3 Transfer of ownership
The VAT obligations are determined to who is deemed to 'own' the products at the time of sale. Whilst this might be clear from a contractual perspective, it is not always obvious from a tax viewpoint. Issues to be considered include who is responsible for transportation and insurance of the goods at all times.

KEY EVENTS

- NAV/share of EUR 120.5-2 by June 30, +32% from March 31 and +153% from the start 2 years ago
- Green Power has further strengthened its project pipeline and it is now over 11 GW, with over 2500 MW of approved grid rights. Over summer, most applications will be confirmed or rejected by the grid operators and approvals will be positive for the pipeline value. The company expects to have the first projects ready to sell in Q1 2024.
- The company has solved its financing needs through loans of over GBP 10 million and has the funds needed until projects have been sold. The combined effect of the larger project portfolio and the removal of the financial risk discount previously applied results in a valuation increase of close to +100%.
- Ringtail has largely been funded by bridge loans from Klint Ventures during Q2. External funding of 2 MUSD has been secured with further financing in process.
- After several discussions with game studios regarding the pre-Alpha, Ringtail decided to focus on the development for the current customer and the development of a share issue round during the quarter and have signed the formal agreement for a full roll-out for the customer Jernhusen.
- Telcred completed a valuation increase for Green Power, the valuations of Storekey and The Park are reduced by 50% in the quarter.

- Storekey has been selected to participate in the Pergaus Portfolio. Only 300 start-ups in the portfolio are currently the only Swedish start-ups
- Storekey raised EUR 1.5 million in a Series A round in March. KV subscribers are holding off the less-making sure on the company
